Department of Philosophy and Religious Studies Annual Departmental Report for 2008 Submitted by Mary Sirridge, Spring 2009

Administrative:

- 1. The proposal for a separate Religious Studies BA was refiled with the revisions required by the Board of Regents. However, REL had filed an updated curriculum, which had passed CAPPE and C&C at the Academic Affairs level;
 - The proposal that was refiled incorporated the required revision per the recommendation of the Board of Regents. Thus
 - The proposal submitted in accord with those recommendations of BOR found itself not in keeping with curriculum approved in the meantime by CAPPE and C&C, i.e., in keeping with no extant approved curriculum;
 - and so the whole REL curriculum had to be resubmitted, this time in line with the BOR recommendations;
 - And all the curriculum changes for Philosophy and Religious Studies, including changes
 to bring us in line with the new College requirements and reduction of the total number of
 hours in the major, were tabled by the Registrar's office pending the approval of the now
 delayed, but refiled, REL BA;
 - The REL BA now falls under the moratorium on new programs. Confused? You should be. But the bottom line is that we are the only department in the College with the old requirements (6 hrs of history, 2 hrs. of lab attached to the science sequence, 9 hrs of social sciences distributed over two fields, no one of which may be history.)
- 2. The majority of work for the program review was completed in the end of fall semester, 2008.
- 3. The majority of work for re-submission of courses for GenEd status was completed in fall semester, 2008.
- 4. Mary Sirridge was on leave in Spring, 2008, and Gail Sutherland served as Interim Chairman of the department in Spring, 2008.

- 1. Stephen Finley (Rice University) was hired on a tenure track line in Religious Studies. He has (Spring, 2008) defended his dissertation and will pick up an appointment as assistant professor in Fall, 2009.
- 2. James Rocha (UCLA) was hired as a tenure-track assistant professor in Philosophy starting in fall, 2009.

3. Michael Pasquier (Florida State) was hired as a tenure-track Religious Studies professor, but is spending this year at Harvard on a post-doc and is being replaced by Michael Gueno, who is ABD at Florida State.

- 5. Jon Cogburn, who was still on leave in spring, 2008, returned to full time teaching in fall, 2009.
