#### **Course description**

The purpose of this course is to introduce students to some of the major theoretical approaches in the systematic study of international conflict. The emphasis of this course is on theory, not current events. The semester begins with an introduction to the theoretical and methodological foundations of the international relations subfield, which includes an in-depth treatment of how to evaluate theoretical arguments. This introduction becomes the backdrop for our discussions of several relevant topics in the study of international conflict, such as the role of military power and alliances, the sources of threat credibility in deterrence and coercive bargaining, and other theories. We conclude the class with an examination of issues such as U.S. grand strategies, the problem of terrorism, the ethics of force, and peacekeeping and peacemaking. The goal is not only to familiarize you with the theoretical approaches to international conflict and cooperation, but also to develop the skills to analytically and critically approach the literature in this area.

# **Reading Materials**

There is no required textbook for this course. The required readings are articles and book chapters that are available as PDF files available on Moodle.

#### **Course Requirements and Grading Scheme**

The final grade in this course will be based on three main components: (1) two in-class examinations, (2) Four in-class quizzes, and (3) class participation.

- 1. Two in-class midterm examinations (70% total; 35% each)
- The exams will be a combination of short-answer identification/definition questions and essay questions. Each exam will be worth a total of 35% of the student's final grade. Questions will be based on the student's comprehension of both the assigned reading materials and the class lectures.
- 2. Four in-class quizzes (20%)
- The quizzes are multiple choice and the questions will be based on the class readings and lectures. The dates of the quizzes are not announced, so if you know in advance that you will be missing a class for a university excusable reason, let me know early.
- 3. Class participation (10%)
- Class participation is based on active participation in class discussions. The students are expected to come to class having read the material and able to answer questions and/or engage in informed discussion. This can only be done if you conduct yourselves in a professional manner and are tolerant of other students' ideas, even if they directly contradict you own personal views.
